The monthly report provides information on General Fund revenue and expense performance through November 2020. The 2020 budget was approved with expenses of \$163.7 and revenues at \$163.7 million. The report also includes performance of major revenue sources for the Redevelopment and Tourism funds and capital improvement program.

Statewide revenues continue to fluctuate, presenting challenges to accurate forecasting. After nine months, sales tax is approximately 7.5% under budget, but that shortfall is largely offset by increases in collected use tax (currently applied to online purchases in some situations), which is 29.3% over budget. Income and replacement taxes are also currently over budget, but it is still unknown whether that will continue to year-end. State-shared, unbudgeted cannabis use tax totals \$77,980 year to date. The City's locally imposed 3% tax began July 1 and is higher than initially anticipated. Licenses, inspections and fine revenue are all well under budget and will likely end the year well short of budgeted amounts. The fire shop generated \$217,077 in revenue for mechanical work performed for outside agencies to date.

We are currently projecting a balanced 2020 budget, revenues and expenditures matching, due to additional ambulance revenue, CURES grant funds, and expense reductions in the general fund.

Expenditures are primarily at or under budget. Highlights of expenses to date are outlined below, and detail by budget unit is attached to this memo.

### Public Safety

- Regular salaries and overtime for the Police Department are under budget.
- Regular salaries for the Fire Department are slightly over budget. Overtime is significantly over budget at \$2,237,878 or 230.4%.
- 911 overtime is over budget at \$580,767 or 98.4%.

### Public Works

- Snow and ice expenses total \$3,690,811 at the end of November, or 136% of the total budget.
- Street Division overtime is significantly over budget at \$285,803 or 114.3% of the total primarily as a result of snow operations.
- Road salt is currently well stocked for the 20-21 snow season, and \$142,974 remains for future purchases.
- Pothole patching is on budget at \$1,198,760 or 75.3% of the total.
- In the Traffic Division, street light electricity is under budget at 84.5%, or \$1,943,931.

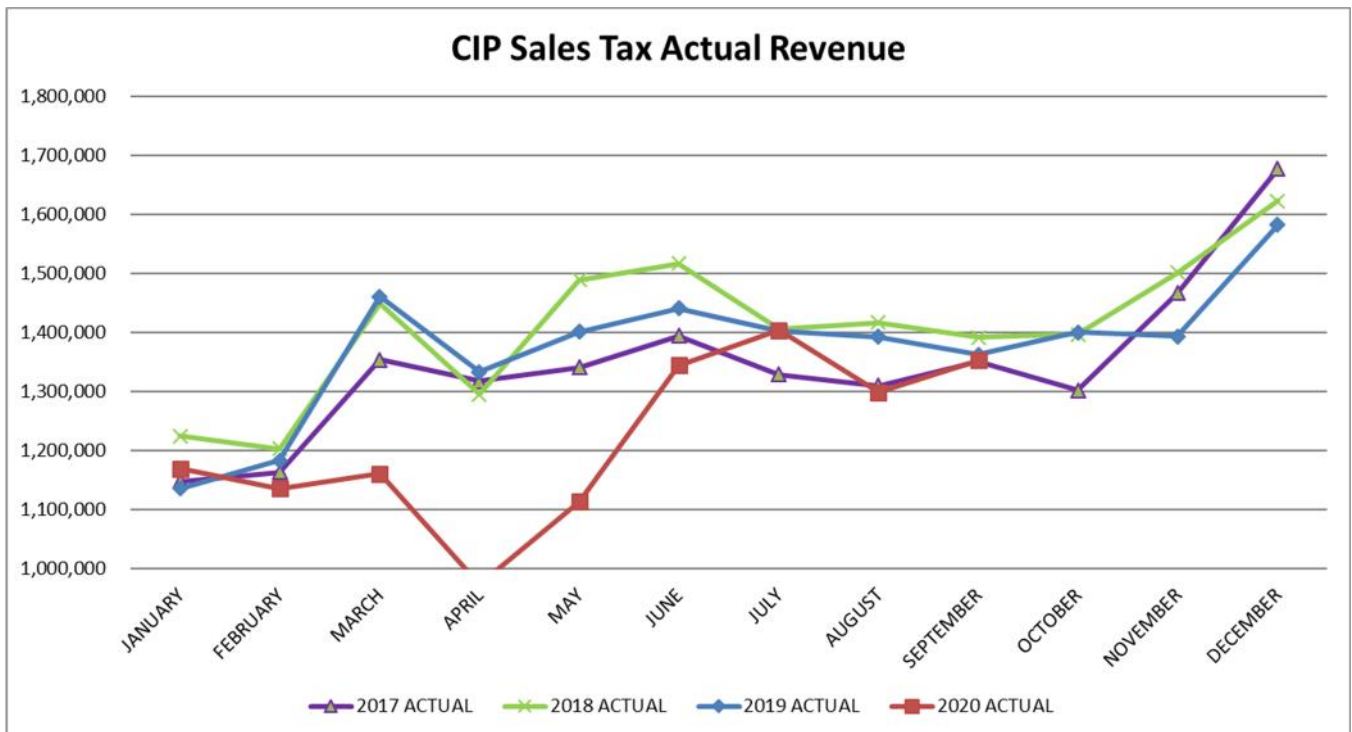
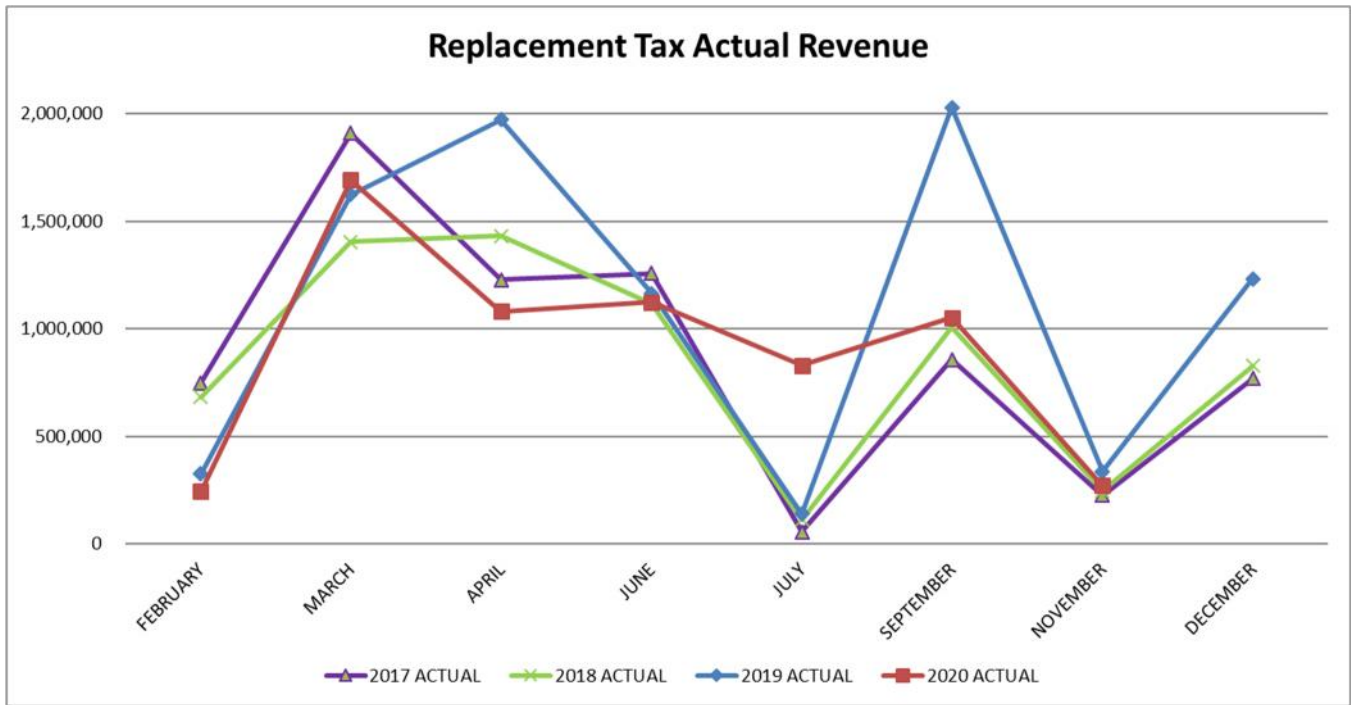


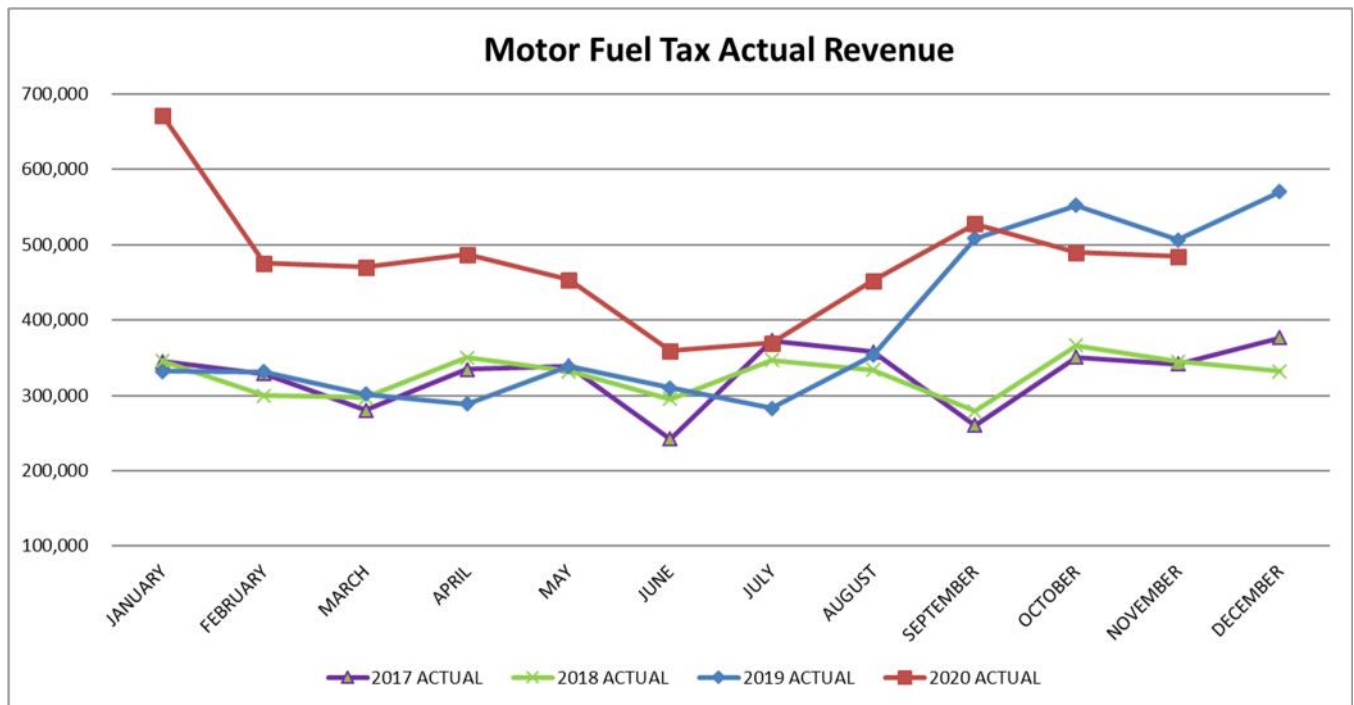
### Income Tax Actual Revenue
