RE: American Rescue Plan Implementation, Phase 1

Staff requests Council approval of the American Rescue Plan (ARP) Implementation, Phase 1, as presented to Council on August 30. The presentation and detailed work to be completed are attached. As discussed at the presentation, the **only** immediate actions occurring upon approval will be the transfer of \$100,000 in operating support to the Redevelopment fund and the posting of the new HR wellness position for hiring. Otherwise, Council's approval today gives staff direction to begin compiling bid specifications and drafting assistance program parameters.

As bids are issued, all contract awards for work to be completed or items to be purchased under this plan will proceed to City Council for approval in accordance with our purchasing procedures prior to implementation.

Programs for disbursement of funds assigned for not-for-profit assistance, housing and community development, workforce development and economic development will be drafted to comply with the provisions in the ARP Act and brought before Council for subsequent approval. We may also partner with local agencies to administer and leverage these funds, those agreements will also come before Council for approval.

In addition to the ARP Implementation, the City has received additional federal funding that we have deployed or are currently in the process of deploying. A brief summary of those dollars is attached.
