The applicant and owner are solely responsible and liable for determining the location of property lines. The City assumes no responsibility for locating property lines.

All dumpsters used to service multi-unit residential buildings and commercial and industrial uses must be screened on all sides by materials that are consistent with the materials used in the principal structure or alternative materials approved by the Zoning Officer excluding wood fencing but including and not limited to finished masonry block, trex board, or steel deck with frame to create a permanent sight obstructing fence with a minimum height of 6 feet. One side of the storage area may be furnished with an opaque, lockable gate.

The property may be subject to the provisions of the HISTORIC PRESERVATION ORDINANCE and/or the FLOOD HAZARD ORDINANCE. The applicant shall be advised accordingly and also informed that the Dumpster enclosure permit CANNOT be approved until after approval has been obtained from the HISTORIC PRESERVATION COMMISSION or the CITY ENGINEER.
